

## **Is it too soon to be planning for retirement?**

### **Not at all.**

Every working person should be giving some thought about how they will handle their finances in retirement. Depending on one's age and the timing of when they want to retire, some people may want to be exploring options and adjusting their plans now.

As a supplement to your existing retirement plans, a Charitable Gift Annuity (CGA) established with the WMU Foundation allows you to leave money to support the mission and ministries of WMU and add to your retirement at the same time. A Charitable Gift Annuity (CGA) allows you to give money to a charity now, enjoy a tax deduction for the gift, and continue to receive an income stream from those funds until your death. At that time, the remaining funds are released to the charity for use as you have requested.

Payment rates are based entirely on your age at the time the CGA is established or when payments begin. For instance, a 55 year old would receive an annuity rate of 4.8% and a 60 year old would receive 5%. However, a 60 year old who defers their initial payment until age 65 would receive a rate of 6.5%; and a 55 year old who defers their initial payment until age 65 would receive a rate of 8%.
